SUBJECT: LOS ANGELES COUNTY (LAC) WORKFORCE INVESTMENT BOARD (WIB) PROGRAM YEAR (PY) 2014-15 REVISED BUDGET

This is to request approval on the attached revised budget.

Funding

The revised budget reflects a \$248k reduction in October 2014 in Rapid Response allocation based on State's recalculation following DOL cuts, which also resulted in \$10k decrease in Adult and Dislocated Worker allocations, resulting in an overall decrease of \$258k. Overall, in PY 2014-15, LA County received a net increase of \$216k in Rapid Response compared to PY 2013-14.

Adjustments

The revised budget reflects adjustments to align with the changes in available funding and to ensure level funding allocations to our contractors for continuous services for this fiscal year and to reflect correction to the initial FY 2014-15 budget. Areas of major adjustments include a \$211k decrease in our Rapid Response program to align with the reduction in State allocations. In our Youth Program, an adjustment is made to correct shift of funds from Administration to Youth Transition/Ramp Down made and presented at the September 24, 2014 WIB Board Meeting.

America's Job Centers of California

This includes funding to support consolidated and collocated Adult, Dislocated Worker and Out-of-School Youth Programs and Services at Job Centers for the fiscal year to enable the County to initiate alignment of services provided at current A/DW Job Centers with new mandates in WIOA. These funds are set aside to ensure that each Center could deliver a consistent level and quality of service and staffing to achieve new and higher performance requirements. Funding is intended to cover operating costs, increased staffing requirements and competitive compensation to reduce turnover rates, as well as all other costs related to the first phase of implementation towards a franchise model throughout our system countywide.

Veteran Services

WIOA maintains a priority of service to Veterans and allows additional customer support to individuals with barriers to employment, including veterans. This line item provides funding to support a countywide Veterans Employment Center, where Veterans are trained and hired to provide employment and training services to other Veterans. Other local WIBs and key veterans service organizations are expected to fund and support this Center. This innovative approach to serving a hard to serve population that is the nation and states' highest priority, is the L.A. County WIB's flagship initiative that is unique to a small number of visionary and high performing boards nationwide.

In-School Youth

Under WIOA, a minimum of 75% youth formula allocation must be used for out of school youth; the WIB approved a policy following adoption of WIOA that 100% of this funding will be dedicated to Out-of-School youth. WIA requires a minimum of one year of follow up activities each quarter at a minimum with all enrolled and exited youth participants. This funding is designated to complete the required follow up of In-School Youth who had received services in the previous fiscal year.

Out-of-School Youth

Funding has increased to expand services to this population consistent with WIOA and the WIB's decision. In addition WIOA requires that 20% of the youth allocation be directed towards work based learning, such as training, wages, and apprenticeships. Funding will serve out of school youth ages 17-24 to attain post-secondary training, degrees or credentials and/or subsidized employment in high growth industries. Target populations include disconnected youth who are low income, Foster, Probation, Homeless, CalWORKs, and disabled youth.

Training and Wages

Funding specifically budgeted for Adult and DW training, as required by SB 734. Approximately 50% of these funds are designated for placement in training for jobs and careers in high growth industry sectors (Construction, Advanced Manufacturing, Trade and Logistics, BioScience, Hospitality and Tourism, Healthcare). For the Youth programs, funding is set aside to place youth in year-round subsidized employment and on the job training, allowing youth to acquire and enhanced skills crucial for permanent employment.

Information Technology - CWSN, PC hardware and Online Virtual One Stop

WIOA requires local boards to enhance accessibility and effectiveness of services through use of technology. These funds are designated to purchase additional modules and software that will be critical in the new Integrated Services Delivery model at each AJCC. The end result will be an effective Virtual One Stop Center, that will multiply Countywide access points and greatly increase access to services by individuals and employers remotely.

Monitoring

This funding covers fiscal and program monitoring conducted by the Auditor Controller. In addition to fiscal and program monitoring, this budget accounts for additional audits, such as Single Audits, Information Technology, Procurement, Payroll, etc. These audits are crucial to the WIOA Program because they increase the accountability of contract agencies and diminish the County's risk in the management of the program.

Regional Capacity Building and Training

This funding will support training to staff working at the AJCCs and sector based satellites on WIOA requirements and other workforce-related subject matter that allows for continuous quality improvement and expertise in workforce related issues.

Transition (Ramp Down and Close-Out)

Funding to support ramp down and close-out activities of agencies that no longer will have contracts with Los Angeles County is required. Ramp down activities include the transfer all active clients from outgoing to incoming agencies; archive all active clients/files for future monitoring; Close out activities include protection of all financial and administrative assets including inventory of all furniture, equipment, office supplies and case files for warehouse, disposal or redistribution/reallocation.
